G) BC AGM and OMAHA President's Report and Tiering information

New motions have been passed. Our zone met last week (West Kelowna down to South Okanagan), about the tiering zones. These decisions have to be made by July 10th, 2016. West Kelowna was reluctant to agree to all the previous decisions OMAHA discussed. They are looking at just doing this for Bantam and Midget now and not Pee-Wee. This is being discussed (nothing confirmed) is \$1500 per player would cover 3 tournaments, carding fees, paid coach, and a dry-land coach. More information is supposed to be put forth to our association Wednesday June 29th. Our associations' recommendation is that we stay as a Tier 3. One idea about choosing teams, in Tier 1 for example, would entail an association candidate/representative to be an evaluator to try and make things more neutral.

All BC teams except the Pacific team who have 7 turning 8 year olds will be allowed to acquire players and create a team to play other teams/tournaments to play full.
