14) Atom Transition Plan Webinar:

Boyd's comments - Overall not a very informative webinar. The gist of the webinar was a document for a minor hockey Association's to provide their coaches or head coach at the Adam level to facilitate the first three Practices and three exhibition games prior to the start of the season to transition layers into full ice hockey. I believe the efforts that we had last year working with the kids and having the full ice games with all three novice teams accomplished the same task that this document is designed to accomplish. The benefit of the way that we did our introduction is the training of the referees. Overall the document has merit in the sense that the document provides coaches with practice plans. However, the game portion I believe we've already done. I can report at the next Board meeting.

15) **Zone meeting Update**:

Gary attended the meeting on April 19th.

The zone delivery group is basically the "Board" for the 4 OMAHA South Teams. They have been working together for several months, and I was the first person from SOMHA to attend one of their meetings. The upcoming season is year 2 of the 3 year pilot program. These guys are 100% committed to the Zone Team Program, and making it a success. Chuck Gallacher was also there. Here is what is happening.

- Southern Zone will field a Tier 1 and a Tier 2 for Midget and Bantam.
- The ZD group is tweaking the team budget, over the next day two and Submitting to OMAHA's ZONE Program Committee (Chuck and BC Hockey)
- Once the Budget is finalized, in particular the Coaching compensation head Coaches will be Hired. Can be as soon as the end of next week.
- Chuck and the BC Hockey People will conduct the interviews and make the hires.
- The ZD group has the go ahead to book Ice now, paid for by BC Hockey

- The plan is to have an evaluation camp in May, Main Camps early August There will be 3 exhibition games each team late August, first week September.
- The ZD group has the go ahead to Order Jerseys ect ect.
- The Zone Teams will not be based out of any association per se, they will go where the ice is.
- Associations can not hold back players.
- 3 More Districts will be fielding Zone Teams in the Province. Prince George, Yukon and one other.

Discussions

- The gist of the meeting was to begin action. The North, Central and South ZD groups have learned a lot this past season, and have been working hard to bring credibility and confidence into the Zone Program.
- They welcomed me, to the group and described their role, and want a representative from South Okanagan at the Table.
- We discussed our Situation, briefly. "The intent of the program is not to take away or hurt from anyone else's program" there was sympathy for how this will affect our program, but no solutions.
- Recognized the need to release the T3 players as soon as possible. Mid August.
- Chuck said that they do not want to cut back the Midget Team too quickly as there is a lot of dominoes to fall, as BCJHL, KIJHL, Major Midget finalize their rosters.

Still looking for SOMHA representative to participate with the Zone team committee meetings.
